<b>3</b>	<b>Members Open Forum</b> This forum is for any Holybourne resident who is not on the HVA committee to raise any issues related to the village (NB These may be time limited by the Chairman)  Helen Walters gave a quick talk about Cycle Alton, part of ACAN (Alton Climate Action and Network). This is a new cycling group covering the 5 cycling and 4 walking groups in Alton with the aim for Alton to become a more cycle friendly town. One of the issues that has arisen due to Coronavirus is the need to implement changes within the local area to allow social distancing when cycling or walking. The Council has been given money to make these changes and have developed an interactive website where local residents can make suggestions for improvements to the locality. Helen has suggested widening the path outside Andrews Endowed for instance, and that there be a lower speed limit through the village as people are walking in the road to socially distance from the queue of people waiting to get into the shop. Some of these changes will obviously be short lived but others may be adopted on a longer term and it is an ideal opportunity to experiment with some ideas now. This is obviously moving very quickly so ideas need to be put forward as soon as possible. 4.2	<p>Coronavirus related topics - AJ reports that the household waste system is changing from next Monday.</p> <p>From 15 June, all HWRCs will revert to their normal summer opening hours of 9am until 6pm, seven days a week. Anyone wishing to visit a site will need to book a slot in advance. People will be able to book a 30-minute slot up to 48 hours in advance. Bookings can be made online at: <a href="http://www.hants.gov.uk/wasteandrecycling">www.hants.gov.uk/wasteandrecycling</a></p> <p>Telephone bookings, for those without access to the online system, can be made by calling <b>023 8017 9949</b>.</p> <p>Anyone wishing to book a slot will need to provide their name, car registration and, for online bookings, an email address. Bookings will be limited to one slot per household per week. More information about using the HWRCs is <a href="#">available online</a>.</p> <p>Concerns were raised that this may directly result in more fly tipping, especially as GH added that only one appointment per week can be made.
