<b>5</b>	<b>Planning and Development Issues in and around Holybourne / Alton</b>	
5.1	New Planning Applications - Upper Neatham Mill Farm have requested to remove a restriction keeping the house as a bed and breakfast. No objections raised.	
5.2	Treloars - plan to go out to tender in September and during the course of the Autumn they will evaluate tenders and start work on site during spring next year. GH has asked for liaison meetings to be set up to deal with residents' concerns.

5.3	<p>Veolia - the application has now been submitted to Hampshire County Council. Based on this formal application, the No Wey group have triggered the work of 3 or 4 consultants to generate a concrete assessment of the application. The deadline for responses is 14th August. No Wey group have sent out a leaflet to over 5000 homes in the area raising 6 or 7 key concerns. GH advised that there is a full council meeting on 5th August with one of the items on the agenda being the council's response to the application. The County Council have rejected the Eastleigh site as a recycling site so if Veolia change the use from recycling to incinerating there will not be a recycling facility in Hampshire. A regulatory committee is likely to sit towards the end of the year and there is a precedent for local people to address the regulatory committee. JJ is happy to put together a deputation on behalf of HVA. DH will put in an objection on behalf of HVA but has asked for each member to put their objection in as well. GH suggests that the HVA also have a word with Energy Alton to put their views to them. KC will put the No Wey leaflet on the website.</p>	JJ DH KC

6.1	<p>Bonfire Night - RL has spoken to the suppliers who are offering free storage for a year for fireworks that cannot be used. Their prices are the same as last year and they are selling the same type of firework so we can buy the same. The early order reduction of 20% has been extended to the end of August. It was agreed that if we are still having to social distance on the night, it would be extremely difficult to hold the event. A vote was held as to whether we buy the fireworks now and this was passed by a majority.</p>	RL

<b>8</b>	<b>Committee Reports</b>	
8.1	Treasurers Report - Just under £11,000 in the bank. Payments have been received from all but three advertisers. VK hopeful that all the money will be in by the end of August - the end of the financial year. Imminent costs - fireworks and magazine (about £3,000)	
8.2	Friends of the Pond - DH, GH and the Town Clerk have been speaking. The pond is on the agenda for the open spaces meeting on 22nd July when it is hoped that Alton Town Council will agree to take on ownership and the public liability aspects of pond. PC thinks this will go through as he suggested it a while ago and the council had agreed that it be included in the schedule of areas maintained and looked after by the Alton Town Council. Regarding the rat problem, the rat catcher has been out (will invoice shortly) and the problem appears to have gone away.	
8.3	Flood Action Group/Emergency Planning - there are some areas still vulnerable if heavy rains. RL particularly concerned about the conduit under the railway bridge at the bottom of Smithy Close. It needs clearing out. There is a new tenant farmer. PC believes it is Tom Porter and will pass his details on to RL. There is also a culvert blocked at Cuckoo Corner. Whilst it does flood the road, it was noted that there were no houses nearby so it wasn't essential .	PC/RL
8.4	Church - they are looking hard at how to open the church for services. They are hopeful that they might find a solution in August. RL advised that they are looking at a scheme for having services with 20 people, places will have to be booked but the same will need to happen throughout the Parish. The Church of England want to open churches from 1 August. Vicky to send Gordon £50 for petrol for the lawn mower.	VK

It was agreed that we need to determine if there is a need. RL to talk to Gordon Randall. If there is then we should begin to explore the idea. PC will ask some questions of the Town Council.
