4.1	<p>Parking and traffic in the village + speed watch</p> <p>Yellow lines have now been painted at road junctions in the village. This was after extensive consultation including a 1.5hr on site meeting organized by GH with council officials and villagers. JW kindly represented HVA. PC commented that new lines might result in faster traffic speeds which could be a safety issue near the school.</p> <p>The possibility of a 20mph speed limit through the village was suggested but AJ commented that this would go against current policy.</p> <p>The role and remit for the traffic sub-group going forward needs to be considered and defined.</p>	All
4.2	<p>Assets of community value - White Hart and Village Shop/Post Office.</p> <p>CR has lots of evidence to support an application for the White Hart but would like help completing the form. DH to help or find a volunteer.</p>	DH
4.3	<p>Sports Field Trust</p> <p>Nothing to report but DH to try to monitor progress with renewing the lease for the sports field.</p>	DH
4.4	<p>Playground</p> <p>GH reported that £20k had been allocated by ATC for the playground and that the wish list for items which had been drawn up by JJ and KJC was to be discussed at the June Open spaces meeting. This would include equipment for all abilities.</p>	GH

RL reported the very sad death of Sean Baddley, the former tenant of Manor Farm. The committee were shocked to hear this and send their condolences to his family. The Village Hall will be closed for the whole of August while new toilets are installed. PL reported much activity by Open Reach in Complins which is likely to be the installation of upgraded cabling for Broadband.
