<b>4</b> 4.1 4.2 4.3 4.4 4.5	<b>Live Issues and Projects</b> 4.1 Parking and traffic in the village + speed watch A traffic survey has been carried out in the village. GH circulated the results. NW queried the timings on the data as he noted that there were three times as many cars at 2am than 7pm. GH will ask a colleague to look at the data as it doesn't look correct. GH wanted to know what the HVA wanted to do with the data. It did show that 85% of cars are travelling at under 30 miles an hour so that shows that most are under the speed limit. JJ thinks any speeding that takes place, happens at the beginning and the end of village and wondered where the survey was carried out. He would like 30mph signs in the village. GH will investigate to see if we can have 30mph signage and also whether we can borrow the flashing speed signs on a long term basis. With regards to the parking, JJ does not think the double yellow lines at Howards Lane have been painted as per the plan. He will send details to GH and GH will look at this. 4.2 Assets of community value - White Hart and Village Shop/Post Office - David is working with Carey regarding the White Hart. 4.3 Sports Field Trust - discussions are progressing well with renewing the lease. It is thought that the Trustees are now not all retiring and HVA will not be asked to step in. 4.4 Playground - GH advised that the tables have been ordered through the Town Council and should be delivered by the end of next week. Potential suppliers have been asked to provide estimates for the new equipment and once received the HVA will be asked to decide what is wanted. It was agreed that JJ will co-ordinate this and HVA will make the decision. 4.5 HVA constitution changes - DH asked for a discussion on potential changes. Should the chair be elected for a set term - say 2 or 3 years? He would also like officers to be elected and appointed at the meeting after the AGM therefore point 5c of the constitution needs to be changed. With regards to the Lidl plot, there is a planning meeting scheduled for the 5th August and it is possible that the Lidl application will be discussed at this meeting. The planning application is from a developer for a 4 unit facility with Lidl being one of the units. It was noted that this is a full planning application not an outline planning application. A pavement is part of the plans. There will be a substantial amount of money paid from the developer and the HVA could lobby Alton Town Council or the EHDC for a proportion of this money to be spent in Holybourne.</p> <p>Veolia - Recycling facility - This may go before the regulator committee on 28th July. If this happens, notices will come out shortly.</p> <p>New Local Plan - Development at Chawton Park Farm for 1200 houses has been included on the plan and is causing controversy. Neatham Down is still on the list of possible sites but not currently on the list for development because the Planners consider the A31 to be a "Physical and psychological boundary". Parish and Town Councils are giving presentations tomorrow evening and the various sites that are in the plan to be progressed will be looked at closely.</p> <p>Alton and District Residents' Association - The next ADRA meeting will be on Monday 19th July to talk about the local plan. ADRA are against the houses being built at Chawton Park Farm.</p>	<p></p>

JR will find out whose land the trees are on and apply for the planning permissions.</p> <p>Flood Action Group/Emergency Planning - there is nothing to report. RL will get back into contact with Highways to see what is happening with the drains and he still needs to speak to the tenant farmer at Brockham Hill. JJ reported that with regard to the flood outside his house, Hampshire County Council has said that they are going to sort it in August.
