1	Opening of Meeting and Apologies for Absence	
1.1	Jerry Janes (JJ) opened the meeting standing in for Rob Law (RL) and accepted apologies from RL, Caroline Wallis and Celia Wood.

3	Members Open Forum	
	JJ invited Andy Hankin and Bob Page to given a resume of their work on the pond, springs, bournes and drainage within the village. Andy Hankin has undertaken an in-depth (no pun intended) survey of the pond and has identified a number of internal springs feeding it. He has also confirmed, with Bob, that the flow of water from around the side of the weir is not from a pond leak but is a separate spring outflow. BP's calculations would indicate that if it were a leak, the pond would have drained within hours. They have also surveyed springs and bournes within the village, including the proposed development site and have indicated these on a map. This is all recorded in this edition of the Holybourne Village Magazine.	
4	Current Issues Events and Projects	
4.1	Village Picnic. At present we are still waiting on a response from The Lawns to see if we can hold the picnic there. The proposed date of 12 th July (as arranged with the Cricket Club) still stands, however it may change when we finalise a new venue. The restrictions on the use of the sports field will effectively rule out its use for this activity.	
4.2	VE Day: This year, the 8 th May will be the 80 th anniversary of VE day. Information on Holybourne's participation in this national event has been posted on our website and social media outlets. The participation on the 8 th May will be a gathering at the War memorial at 9:00 pm (21:00) for lantern lighting and an act of remembrance. Villagers are also encouraged to have street parties on 10 th as well.	
4.3	Fireworks: RL has demonstrated a method of securing the fireworks which will meet the restrictions imposed by Historic England. We can therefore go ahead with the fireworks display on the sports field. There will be an expense to construct the securing units which can be used for all future events too. It is thought that £200 will cover the costs. Cllr Graham Hill said that he holds a sum of money which can be used for local projects and that we should apply to him to fund this expense. We should endeavour to get full early advertisement of the event to prevent a reoccurrence of last year's problems.	RL/ FrWks team

 4.4 20MPH speed limit through village. JJ invited Paul Susans (Our 'lollypop man') to speak. PS said that at present HCC are still funding the crossing patrol outside Andrew's Endowed but as he will be retiring fairly soon he would like to think that the safety of this crossing point will be secure in the future. He Is concerned that cars continue to speed through this part of the village and indeed some do not even heed the use of the lollypop (This is a legal road sign which must be obeyed). Incidents of non-compliance have been reported back to Sarah James HCC school crossing supervisor. There has been substantial village support for a 20 MPH speed limit to be introduced throughout the village and this would go a long way to securing the future safety of the crossing. A paper on this subject was submitted to the HVA and can be found on the HVA Website. We discussed other complementary methods such as flashing signs at the school, speed indicators and speed humps. (Speed indicators fixed to suitable posts cost around £3000). Speeding through urban areas is a known problem and all councillors are actively in support of tackling the issue. Clir A Joy has long campaigned for a 20 MPH limit across the urban area (including Holybourne) and will also raise it at the next ATC meeting supported by our ATC councillors Clir GH and Clir DH. 4.5 Proposal to form a Parish Council: this is an ongoing project but has been slightly delayed. 7.3	Friends of the Pond Andy Hankin gave an update on the pond concurrent with his and Bob Page's summary earlier. Silt is the major problem in the pond and is still coming in through the road drainage picking up the run-off from the fields and Brockhamhill Lane. The farm will help us remove the silt provided that we complete all the legal requirements. This will involve toxicity testing of the silt and a budget quotation of £3,422 has been obtains for this service. Cllr Don Hammond believed that this was excessive and said that he would contact the firm to see if there could be any movement in this price. The spring which surfaces by the weir is thought to be somewhere within the church grounds near the west door. He would like to undertake a Ground Penetrating Radar survey to finally locate the actual spring. This can then be logged on the extensive survey he and BP carried out (featured in the HVA spring magazine).	Cllr DH
